Whitman County has received 46 new positive COVID-19 test results over the holiday weekend and today, bringing the County total, to date, to 2830. 10 cases are currently hospitalized. All other cases are stable and self-isolating.

1 new COVID-19 death reported today. The individual was a Whitman County resident, a male between 60-79 years old. The death occurred outside of Whitman County. Total COVID-19 confirmed deaths, to date, for Whitman County is now 23. Whitman County COVID-19 death counts are confirmed by the Whitman County Coroner and Public Health Department. There may be a delay verifying COVID-19 as cause of death for individuals who die outside of the county due to necessary confirmation.

Whitman County has begun the process of COVID-19 vaccine administration in partnership with local area providers. Whitman County Public Health is currently in Phase 1A of the phased distribution framework laid out by the CDC and the Washington Dept. of Health.

As more vaccine becomes available and supplies allow us to move into Phase 1B we will follow all CDC and DOH guidance to prioritize distribution. At that time, we will use all available communication channels in Whitman County to inform those members of the public that qualify for Phase 1B administration how they can receive the vaccine and will be regularly updating our website with this information. In addition, we would like to express our heartfelt thanks for all of our healthcare workers who have done so much to get this life-saving vaccine to those in our community that need it most.

Indoor social gatherings in the State of Washington are restricted from November 17, 2020 to January 11, 2021 unless:

- All participants quarantine for fourteen (14) days prior to the social gathering.
- All participants quarantine for seven (7) days prior to the gathering, and receive a negative COVID-19 test result no more than 48-hours prior to the gathering.

Gathering with people you don't live with – even close friends and family – may spread COVID-19. The safest action for everyone is to avoid gatherings, even outdoors, and find different ways to celebrate this season.
